# Privacy

**Minack.info** is committed to developing long lasting relationships based on trust. **Minack.info** will do everything in its power to ensure that your right to privacy is maintained and protected. This Website is not directed at children under 13 years of age.

#### Information Minack.info Collect

**Minack.info** may request or collect personal information from online users in a variety of ways, including through online forms for ordering products and services, and other instances where users are invited to volunteer such information. The information **Minack.info** collects is personal information that identifies you personally, such as:

- Your name
- E-mail address
- Postal address
- Telephone and facsimile numbers
- URL

**Minack.info** may also collect information on how users access the Website by using a tracking ID unique to each user through the use of cookies.

### What are Cookies?

A cookie is a piece of data stored on the user's computer tied to information about the user. **Minack.info** may use both session ID cookies and persistent cookies. For session ID cookies, once you close your browser or log out, the cookie terminates and is erased. A persistent cookie is a small text file stored on your computer's hard drive for an extended period of time. Your browser's help file contains information and instructions for removing persistent cookies. Session ID cookies may be used by **Minack.info** to track user preferences while the user is visiting the website. They also help to minimise load times and save on server processing. Persistent cookies may be used by **Minack.info** to store, for example, whether or not you want your password remembered, or other such information. Cookies used on the **Minack.info** Website do not contain personally identifiable information.

Log Files

Like most standard Websites, **Minack.info** use log files. This information may include internet protocol (IP) addresses, browser type, internet service provider (ISP), referring/exit pages, platform type, date/time stamp, and number of clicks to analyse trends, administer the site, track user's movement in the aggregate, and **Minack.info** gather broad demographic information for aggregate use. However, none of the information stored in the log files, including but not limited to IP addresses, is linked to personally identifiable information.

#### How Minack.info uses this information

**Minack.info** may use the personally identifiable information collected by **Minack.info** to contact customers regarding products and services offered by **Minack.info** and, to the extent the User has agreed to it, by its trusted affiliates, independent contractors and business partners. **Minack.info** may also use this information for research purposes regarding the effectiveness of Website services, marketing, advertising and sales efforts. **Minack.info** will not in any way share this information with a third party either for free or by selling it, unless you specifically authorise such disclosures.

#### Disclosure of Information

**Minack.info** may also disclose aggregate, anonymous, data based on information collected from Users to investors and potential partners. In such cases, statistical information only will be disclosed and personally identifiable data will be kept strictly confidential.

**Minack.info** may from time to time engage third parties, to preserve, analyse or otherwise store or manipulate data received by **Minack.info** from its customers. In all such cases, such third party service providers will be required to treat all such data with the same degree of care **Minack.info** and they will be prohibited from disclosing such data to any other person or party, except as otherwise provided for in this Privacy Policy.

#### Service Announcements

On rare occasions it is necessary to send out a strictly service related announcement, if, for instance, a service is temporarily suspended for maintenance. Generally, users may not opt-out of these communications, though they can deactivate their account. However, these communications are not promotional in nature.

Though every effort is made to preserve your privacy, **Minack.info** may need to disclose personal information when required to by law. If it is deemed necessary that such action needs to be taken, **Minack.info** will comply with judicial proceedings should a court order or legal process be served on **Minack.info**.
